**NEW ALBANY - FLOYD COUNTY PARKS & RECREATION
2012 SPRING VOLLEYBALL LEAGUE INFORMATION**

1. Total fee is \$200.00 per team for a minimum of 8 games (tournament games included in minimum). Payment is due at the time you register. Registration opens Monday February 27, 2012. Deadline to register is Friday April 6, 2012. We accept cash, check, and credit card.
2. Team roster/waiver forms are due at the start of your first game. Last date for roster changes is before the start of your third played game.
3. Each team plays one game per week (Bye week may be instituted if necessary) and a single-elimination tournament at the end of the Regular Season.
4. The Parks Department must have at least four teams to run a league. The Parks Department reserves the right to place teams in the league.
5. NA-FC Parks and Recreation & SISC will provide game balls.
6. Leagues will begin the week of Monday April 16, 2012.
7. T-shirts will be awarded to league winners at team request. Logo/design will be chosen by the Parks Department. **No** special order shirts will be provided.
8. All checks are deposited daily. Any returned checks will be subject to a returned check fee (\$25). If a team drops from the league before the league starts, a refund will be issued if another team can be found to replace that team. If another team cannot be found, half the fee will be refunded. No refund will be issued after the start of the season. The refund will be issued in four to six weeks.
9. All players participating in the NA-FC Department of Parks and Recreation Volleyball Leagues must sign the roster/waiver provided by the Parks Department. The Parks Department is not responsible for any injuries that may occur while participating in our leagues.
