2010 SUMMER VOLLEYBALL LEAGUE INFORMATION**

1. Total franchise fee is \$200.00 for 8 games (one or two games a week) and a tournament. Balance of \$200.00 is due by Monday July 19, 2010. We accept cash, check, and credit card.
2. Roster/waiver list is due by Monday July 26, 2010. Signatures will be collected by the scorekeeper before your first game. Last date for roster changes is before third game is played.
3. Four to Eight weeks of play, 8 games. Each team plays one or two games per week. (Monday and/or Wednesday) There will also be a Single-Elimination Tournament at the end of the Regular Season
4. The Parks Department must have at least four teams to run a league. The Parks Department reserves the right to place teams in the league.
5. NA-FC and SISC will provide game balls.
6. Leagues will begin the week of July 26, 2010.
7. T-shirts will be awarded to league winners at team request. Logo/design will be chosen by the Parks Department. **No** special order shirts will be provided. Please make request within 2 weeks of the end of the league.
8. Sponsor plaques or trophies will be awarded to tournament winner at team request. Please make request within 2 weeks of the end of the league.
9. All checks are deposited daily. Any returned checks will be subject to a returned check fee (\$25). If a team drops from the league before the league starts, a refund will be issued if another team can be found to replace that team. If another team cannot be found, half the fee will be refunded. No refund will be issued after the start of the season. The refund will be issued in four to six weeks.
10. All players participating in the NA-FC Department of Parks and Recreation Volleyball Leagues must sign the roster/waiver provided by the Parks Department. The Parks Department is not responsible for any injuries that may occur while participating in our leagues.
